

A Guide of processing 'Expected Graduation' in August 2026

Graduating students in 2026 spring semester (August 2026) must check your status as 'Expected Graduation' on SAINT and read the guide below carefully to avoid any issues with the graduation.

1. Processing 'Expected Graduation'

A. Eligible students

- Only enrolled students in the 2026 spring semester from 8th semester or later can be eligible.
- Students who completed all the graduation requirements of your graduation table are eligible. (Total credits, The number of major courses in English, CGPA and so on.)
- In case of students who applied for early graduation (6th and 7th semesters), the process will take place in April.
- In case of students majoring in Chinese Culture and European Culture, and completing all requirements only except for submitting language certificate also will be eligible to be 'Expected Graduation status.'
- The students whose class is 2022 or later must submit additional language certificate.
- If the student did not submit the certificate until at the end of this semester, that student finally cannot graduate in August

B. Benefit concerning FA (Failure by absence)

- Students processed 'Expected Graduation' have a benefit of allowable limit about FA. For example, students can be absent up to 4 times on 3 credit course and get FA when 5 times. If their status is 'Expected Graduation', they can be absent 8 times and get FA when 9 times.
- ✗ Though students get F or FA from one course, other courses are independent of that course.

The benefit of allowable limit of other courses will be maintained until at the end of this semester and students can get grades from the courses.

- C. After getting status 'Expected Graduation', if the condition of students is changed (changing courses, major, leave of absence etc.), the process can be canceled.

D. Date of process

- * Because of counting issue of mandatory liberal arts courses on graduation requirement table, expected graduation of international students will be slightly delayed.

E. Check the status on SAINT portal :

2. Graduation confirmation and delay

- International students cannot delay the graduation because of visa issues. If they completed all the requirements of graduation in 26-1 semester, they must graduate in August, 2026.

=> If you have other types of visa, not D-2, with confirmation of Int'l office, we can make your status "graduation delay" on August 2026.

3. Other information

A. Final check of the graduation result.

- Students can graduate if they complete the requirements with course completion in the Summer semester.
- If they finally get F or FA and don't complete the requirements, they cannot graduate in this semester.
- Check the submission of language certificates in case of students majoring Chinese culture and European culture.
- In case of students applied for early graduation, they must finish all requirements until 26-1 semester. (Summer courses are not counted for the result)
- Students on leave cannot graduate in 26-1 semester in spite of the completion of graduation requirements
